Ri Bhoi



On August 23, 2023, DPMU team visited Nongsangu village in Umsning Block. The purpose of the visit was to verify data for the Forest Management Plan (FMP) under the Payment for Ecosystem Services (PES) initiative. This program promotes sustainable forest practices and compensates landowners for maintaining ecosystem services. Nongsangu village, standing over 400 meters high, ranks in the top ten peaks of Ri-Bhoi District. This elevation contributes to its unique ecology, emphasizing the need to protect its resources. The visit underscores local communities' role in preserving valuable ecosystems.



On August 24th, EE-EM from Ri-Bhoi DPMU conducted a visit to Umshaken Raid Mathan Village in the Umsning Block. The visit aimed to validate data for the Forest Management Plan (FMP) as part of the Payment for Ecosystem Services (PES) program.



EE-Accounts visited Maker and Mashang Villages in the Umsning Block to collect UCs for the Forest Management Plan and review Excess Fund utilization. The visit also involved updating accounting records.

DISTRICT WISE ACTIVITIES

Notably, two VECs are actively engaged in ongoing project work, highlighting sustained efforts towards project goals. After discussions with the APO, a joint inspection is planned to monitor activities at the project sites.

Empowering Community Development: MSP cum AGM Series in West Khasi Hills, West Jaintia Hills, and East Garo Hills IVCS



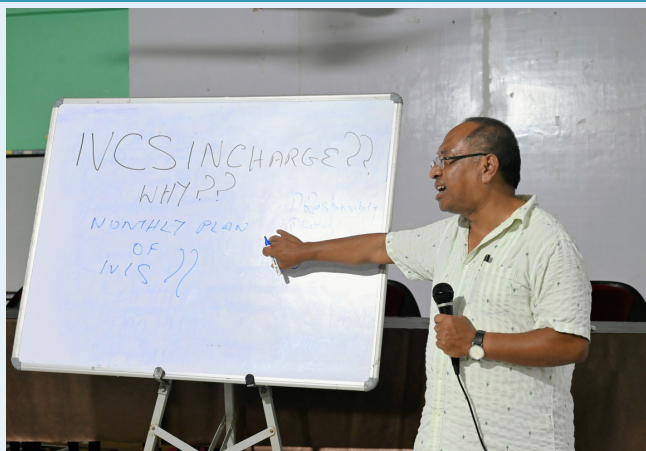
A series of Multi-Stakeholder Platform (MSP) cum Annual General Meetings (AGMs) was conducted across various Integrated Village Cooperative Societies (IVCS) in West Khasi Hills, West Jaintia Hills, and East Garo Hills. These gatherings were held at Langpih IVCS, Ktiehthawiar IVCS, Langumshing IVCS, Nongriangka IVCS, Umdang IVCS, Songsak IVCS, Nongriangba IVCS, Nengchigre IVCS, Rongkhugre IVCS, Nongshram Adeng IVCS, Umthlu IVCS, Dorangre IVCS in West Khasi Hills, Mookyniang IVCS in West Jaintia Hills, and Chram IVCS in East Garo Hills District. The objective of these meetings was to synergize efforts and deliberate on crucial agendas for advancing community development.

In the presence of officials including the Junior Cooperative Officers from the office of the Assistant Registrar Cooperative Society, staff from the District Project Management Unit, and IVCS members, the discussions centered around pivotal subjects such as adopting new By-Laws, presenting annual IVCS reports, and emphasizing the strategic significance of elements like Service Provider training, Farmers Field Schools, and Processing Units. Participants also explored the expansion of the IVCS's operational scope and the reassessment of office bearers.
